



PROFESSIONAL WOMEN'S BOWLING ASSOCIATION OFFICIAL RULES AND REGULATIONS

The official rules and regulations of the Professional Women's Bowling Association (PWBA) govern competition, policies, and procedures for all PWBA tournaments, and tournaments conducted for others by the PWBA.

All rules and regulations contained herein are at the Tournament Director's discretion. Competitors have the right to appeal a Tournament Director's decision to the Senior Director of Collegiate/Short Duration Tournaments or Executive Staff.

All PWBA tournaments will be USBC-certified. The game of American tenpins will be played.

They are scratch singles tournaments with qualifying rounds, match play and stepladder finals. All participants give PWBA their unqualified permission to use their photograph for publicity purposes, to arrange for the telecasts or broadcasts of the tournament without cost to the participant and without sharing revenue derived therefrom with them.

PART ONE - GUIDELINES

1. Good Standing – "Good Standing" shall include past and present compliance with PWBA rules, regulations, policies and standards; with any and all financial obligations to PWBA and associated parties paid in full.
2. Parental Consent – All applicants under the age of 18 must submit written parental consent to compete in PWBA events.
3. USBC Membership – The PWBA recognizes the USBC is the national governing body of bowling. All tournament competitors must be USBC members in good standing.
4. SafeSport Training – The PWBA is committed to ensuring the safety of all competitors, especially those competitors under the age of 18 who may participate in PWBA events. Therefore, all PWBA tournament competitors must be SafeSport-trained prior to competing in any PWBA events.

PWBA PLAYER, ROOKIE OF THE YEAR AND HIGH AVERAGE AWARDS

- A. Player of the Year – The official award to be known as the PWBA Player of the Year shall be determined annually by competition points. The PWBA Player of the Year must be in good standing with the PWBA.
- B. Rookie of the Year – The official award to be known as PWBA Rookie of the Year shall be determined annually by competition points. Eligibility criteria shall include:
 1. A PWBA competitor may not have bowled in eight (8) or more PWBA national tournaments after 2015, including the USBC Queens and the U.S. Women's Open.
 2. A PWBA competitor may not have bowled in three (3) or more national tournaments in a single PWBA season.
 3. Participation in a PWBA Pre Tournament Qualifier (PTQ) event shall count as a tournament bowled.
- C. High Average – The official award to be known as the PWBA High Average Award shall be determined annually by taking the total number of pins by qualified players and dividing the total by the number of games bowled in the season. The winner of the award must be in good standing with the PWBA and have bowled at least 60% of the events during the PWBA Tour season. Pinfall from the following events will not count toward this total:
 - PBA/PWBA Striking Against Breast Cancer Mixed Doubles
 - PBA/PBA50/PWBA Trios (if applicable)

PART TWO – COMPETITION RULES

Rule 1. TOURNAMENT ENTRY AND COMMITMENT

- A. Obligation to Compete – Payment of entry obligates a competitor to compete in that tournament and participate in a related pro-am/sponsor event for that tournament. See Rule 3 for Bowl with the Pro obligation.
- B. PWBA Standard Event Eligibility – Standard Events are open to any female competitors who have achieved an average 190 or higher in any USBC certified league. Competitors living outside the United States may enter with proof from their country's federation.
- C. Entry Deadline Standard Events – Deadline for filing of entry to PWBA tournaments shall be twenty-one (21) days prior to the start date of the tournament. Tournament start date is the date designated as the official practice day. Any late entries shall be assessed a \$50.00 administrative fee. PWBA may establish entry deadlines and late entry penalties in exception to this rule for special events at its discretion.
- D. Priority for Acceptance of Entries, Standard Events – The entry field will be set to accommodate the maximum number of competitors, subject to the number of lanes available and no more than five (5) competitors assigned to any pair of lanes, which will constitute a full field. Entry priority will be in the following order prior to the 21-day deadline:
 1. PWBA Hall of Famers
 2. PWBA National Champions (regardless of membership status at the time of win)
 3. Top 50 players from the previous season point list
 4. Other eligible competitors based on date of entry.

If any other eligible competitor (No. 4 above) attempts to enter a tournament at a time when only ten (10) spots remain in the tournament proper, they will be placed on the PWBA Qualifier list.

- E. PWBA Standard Event Qualifiers – May be conducted only if the field is full prior to the 21-day deadline. Other eligible competitors (No. 4) wishing to enter a PWBA event will be placed on the PWBA Qualifier list and will either be confirmed into the tournament proper or into the field for the PWBA Qualifier 21 days prior to the start of the official tournament competition. The number of spots available for the PWBA Qualifier will be determined by the difference between the size of the field and the total number of qualified competitors (No.'s 1, 2 and 3 on the priority list above) entered in the event. Up to ten (10) spots will be held for the PWBA Qualifier, although this number may be larger. At the time of the PWBA Qualifier, if the number of competitors entered in the PWBA Qualifier is less than the number of spots available in the tournament proper, then all competitors will be confirmed into the tournament proper and the PWBA Qualifier will be canceled. Any competitor who competes in the PWBA Qualifier but does not qualify for the tournament proper will be refunded one-half of their entry fee.
 1. Participation in a PWBA Pro Tournament Qualifier (PTQ) event shall count as a tournament bowled.
- F. Entry Fee Payment Standard Events - Payment for confirmed entries (\$400) will be collected at the time of entry. All entry fees and any other financial obligations must be paid in full prior to the start of competition.
- G. Tour Championship Eligibility – The Tour Championship field will be a 24-player field. To qualify for the Tour Championship, you must be in good standing with the PWBA and have won a National Tour title during the current season. The remainder of the field will be filled from the PWBA season points list through the most recent tournament preceding the Tour Championship.
 1. If a direct entry (National Tour Champion) declines her invitation or does not pay her entry fee by the registration deadline, her spot will be deferred to the next available competitor on the season points list and a sliding scale will be used to fill the open spot.
 2. Competitors that qualify via points must participate in a minimum of 50% of the season events. If a qualifying entrant (season point list) declines her invitation or does not pay her entry fee by the registration deadline, her spot will be deferred to the next available competitor on the season points list and a sliding scale will be used to fill the open spot.
 3. The PBA/PWBA Striking Against Breast Cancer and the PBA/PBA50/PWBA Trios (if applicable) champions are not eligible as PWBA points are not awarded in those events.

4. The alternate must be in good standing with PWBA and will be the first competitor outside of the 24-player field. If a competitor declines to serve as the alternate, that spot will be deferred to the next available competitor on the season points list on a sliding scale until filled.
5. Tour Championship entry fee is set at \$500.

H. PWBA Regional Eligibility – Regional tournaments are open to the following competitors:

1. Any female competitor who has achieved an average of 180 or higher in any USBC certified league.
2. Any PWBA National Champion that hasn't won a title in the last 15 years.

I. PWBA Regional Showdown Eligibility - The champions from each regional tournament during the season will receive an automatic entry in the Regional Showdown. They will be seeded directly into the round-robin match play portion of the event via a random drawing. The remainder of the 18-player field will be determined from an eight-game pre-tournament qualifier. Entry will be open to anyone who meets the Regional Eligibility requirements.

1. If you win a regional tournament, then win a National tournament in the same season, you remain eligible for the Regional Showdown but you are no longer eligible for regional tournaments.
2. If a direct entry (Regional Champion) declines her invitation or does not pay her entry fee by the registration deadline, her spot will be filled from the qualifier.
3. If a competitor that qualifies via the pre-tournament qualifier declines her spot in the 18-player field, we will defer to the next competitor from the qualifier and a sliding scale will be used to fill the open spot.

J. Field Size, Entry Fee, Priority and Deadline for Acceptance of PWBA Regional Entries – The entry field will be set to accommodate the maximum number of competitors, subject to the number of lanes available and no more than five (5) competitors assigned to any pair of lanes. Confirmed entries (\$200) will be collected at the time of entry. All entry fees and any other financial obligations must be paid in full prior to the start of competition. Entries will close forty-eight (48) hours prior to the start of the event and will be accepted on a first-come, first-served basis. The Tournament Director has the right to extend the entry deadline.

K. Tournament Standby List – Prior to the Event Start - A standby list will be created when all available spots have been filled.

1. Competitors on the standby list will be notified via phone call and/or email when a spot in the tournament has become available. They will have 24 hours to accept or decline the spot. If the competitor fails to respond to the Tournament Director within 24 hours, we will go to the next competitor on the waiting list and a sliding scale will be used to fill the open spots.
2. A competitor not available to bowl at the official starting time posted for her first round will be disqualified and replaced by the next standby in line, in the tournament venue. If the first person on the standby list is not present, a sliding scale will be used to fill the open spots.

L. Executive Staff Entry – Executive Staff of the PWBA can invite players to compete in a PWBA event and bypass the PWBA Qualifier.

M. Right to Refuse Entry – In accordance with the rules of the sport of bowling as defined by the United States Bowling Congress, the PWBA reserves the right to refuse or reject any entry prior to the time of bowling.

Rule 2. WITHDRAWAL FROM A TOURNAMENT

- A. Withdrawal Prior To Start – Competitors may withdraw from an event up to fourteen (14) days prior to the start date with no penalty. After that date, a \$50 administrative fee will be charged for withdrawal. Any notice of withdrawal can be made in writing or by telephone with the Tournament Director. Any withdrawal after the start of the official practice session will result in forfeiture of entry fee. Failure to report withdrawal according to procedures as defined will cause forfeiture of entry.
- B. Withdrawal While Tournament is in Progress – Withdrawal of any competitor while the tournament is in progress will not be permitted until all competitors on the pair have been informed and permission has been granted by the Tournament Director. See Rule 24: Fines and Penalties.

C. Withdrawal From TV Finals – A competitor who withdraws from a TV finals match shall forfeit the match, even if she has accumulated enough pins to win without completing the game.

Rule 3. BOWL WITH THE PRO TOURNAMENTS

A commitment to enter a tournament is also a commitment to participate in a related pro-am at the tournament host center or in a host and/or tournament sponsor function. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

A. All competitors entered in a tournament must be available to participate in the related Bowl with the Pro, host center and/or tournament sponsor function. All competitors scheduled to participate must report to roll call and fulfill their Bowl with the Pro obligation as required.

1. To be excused from a Bowl with the Pro, host center and/or tournament sponsor function the competitor must submit a withdrawal notice to the tournament director from the Bowl with the Pro event a minimum of two days prior to the Bowl with the Pro event.
 - a. The withdrawing competitor is also responsible for finding a suitable replacement for them in the Bowl with the Pro event. Example: A champion must find a champion to replace them on the squad.
2. Further, upon being excused from the pro-am, tournament or sponsor function, the competitor is not permitted to participate in the official practice session at the tournament site the day of the pro-am.
3. A competitor who is excused from the Bowl with the Pro, host and/or tournament sponsor function for any reason will be required to perform a substitute tournament function or may be subject to disciplinary action for conduct unbecoming a PWBA competitor depending on the circumstances of her excused absence.
4. Repeated refusals by a competitor to participate in Bowl with the Pros, host and/or tournament sponsor functions shall be found in violation of the PWBA code of conduct and subject to disciplinary action including, but not limited to, disqualification from future events or fined.
5. At least 90 percent of competitors chosen to participate in a Bowl with the Pro, host and/or tournament sponsor function shall be competitors chosen from the previous week's Points List to a floor of 40 and will be eligible in the order of their standings on such list. The host proprietor or tournament sponsor shall have the right to choose any remaining competitors.
6. Regional Bowl with the Pro competitors will be chosen to participate based on how many regional titles they have won. The host proprietor or tournament sponsor shall have the right to choose any remaining competitors.

Rule 4. FORMATS

A. Standard Event – Each competitor will bowl two blocks of six games each of qualifying. The field is then cut to the top one-third of the field. Those competitors will bowl one block of six games of qualifying. The field will then be cut to the top 12 competitors, who will bowl six additional games of qualifying. The top five players after 24 games will advance to the stepladder finals and compete for the title.

B. PWBA Standard Event Qualifiers – Each competitor will bowl one six-game block of qualifying. Up to ten (10) players will advance to the tournament proper. Although this number may be larger.

C. Series Event Round Robin Match Play - Each competitor will bowl two blocks of six games each of qualifying. The field is then cut to a predetermined number of match play finalists (usually 12 or 16). Those competitors bowl two six-game blocks, or two eight-game blocks, of round-robin match play. At the conclusion of match play the top five bowlers advance to the stepladder finals.

- D. Series Event Bracket Match Play (24 Player Bracket)– Each entrant will bowl two blocks of six games each of qualifying. The field will then be cut to the top 24 competitors. The matches are best of three all the way to the stepladder finals. The top eight qualifiers will receive a bye in the first round. The round of 24 will feature qualifiers nine (9) through twenty-four (24). The round of 16 will feature qualifiers one through eight plus the winners from the round of 24. Winners will advance to the round of 8. Winners from the round of 8 will advance to the stepladder. Positions 1 – 4 in the stepladder will be determined according to the players qualifying seed number. The highest qualifying seed losing in the round of 8 will qualify in the 5th position for the stepladder.
- E. Series Event Bracket Match Play (16 Player Bracket)– Each entrant will bowl two blocks of six games each of qualifying. The field will then be cut to the top 16 competitors. Those competitors will be seeded into a 16-player bracket (1 v 16, 2 v 15, etc.) The top 16 will bowl best of five game matches until the field is down to four competitors. The Championship Round will be one-game matches all on the same pair. The highest remaining qualifier in the semi-finals will be the second semi-final match. The two winners of the semi-final matches will bowl for the title.
- F. Series Event Bracket Match Play with Wildcard Match– Each entrant will bowl two blocks of six games each of qualifying. The field will then be cut to the top 16 competitors. Those competitors will be seeded into a 16-player bracket (1 v 16, 2 v 15, etc.) The top 16 will bowl best of five game matches until the field is down to four competitors and the Wildcard competitor. The Championship Round will be one-game matches all on the same pair. The Wildcard competitor will be the player with the best match play record that didn't qualify for the semi-finals. Should there be a tie with match play records, overall average will break the tie. If a tie still exists, high game will break the tie. The Wildcard match will feature the Wildcard competitor and the player that qualified for the semi-finals with the worst match play record. Should there be a tie with worst match play records, overall average will break the tie, with lowest average having to bowl. If a tie still exists, low game will break the tie, with the competitor with the lowest game having to bowl. The winner of that match will go to semi-final match #2. Semi-final match #1 will be bowled first. Then semi-final match #2 will be bowled. The two winners of the semi-final matches will bowl for the title.
- G. Tour Championship - Each competitor will bowl three eight-game blocks of round-robin match play. All players will be seeded into the round-robin match play schedule according to their position on the season Points List after the last tournament preceding the Tour Championship. The top five competitors after 24 games will advance to the stepladder finals and compete for the title.
- H. Regional – Each competitor will bowl one block of eight games of qualifying. The top four competitors advance to the stepladder finals.
- I. Regional Showdown – The champions from each regional tournament during the season will receive an automatic entry in the Regional Showdown.
 1. Each competitor will bowl three six-game blocks of round-robin match play. The top four competitors will advance to the stepladder finals.
 2. A pre-tournament qualifier will be conducted to determine the remainder of the 18-player field. The pre-tournament qualifier will consist of one eight game block of qualifying.

Rule 5. TOURNAMENT SCHEDULING

Squad Scheduling/Tournament Roll Call – It is the responsibility of each tournament competitor to find out her scheduled squad times for both the Bowl with the Pro and the tournament proper by checking PWBA.com and on-site. All official tournament information will be posted in the players locker room.

1. All competitors must report to the locker room thirty (30) minutes prior to their warm-up of the opening squad of the tournament. Roll will be called prior to the start of each squad of the first round of qualifying and prior to any round that follows a cut to the field. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

2. An information sheet will be posted in the locker room listing each competitor's squad assignment. It is the competitor's responsibility to read the information sheet, comply with its instructions and to be available to bowl at her scheduled starting times. Special opening ceremonies may be held prior to the start of Bowl with the Pro squads, qualifying, match play and stepladder final rounds.
- A. Check-In for TV Finals – Competitors who are to participate in TV Finals are required to be on the premises at least two (2) hours prior to the scheduled finals for a roll call meeting unless an alternate time is specified by the Tournament Director.
- B. Penalties for Late Arrival – Any competitor who is late for the starting time for any subsequent round of qualifying must enter play in the current frame and game in which her group is bowling, and she will receive no score for frames and/or games missed. Bowlers who are late for an earlier squad will not be moved to a later squad.
- C. Official Starting Time – Official starting time for practice, Bowl with the Pro and all rounds shall be as published on the PWBA tournament schedule.
- D. Schedule Changes – Any scheduling changes pertaining to the tournament will be posted in the locker room twenty-four (24) hours in advance. All competitors are responsible for checking schedule changes.
- E. Schedule Changes for TV - Any scheduling changes pertaining to the TV Finals will be made at the discretion of the tournament director.

Rule 6. PRACTICE SESSIONS

- A. Complimentary Practice Session – The host center will make the tournament lanes available on a day and time specified by the PWBA for a complimentary practice session, which shall be available to all competitors entered in the tournament. All practice sessions are optional.
- B. Other Practice Sessions – All tournament competitors are required to pay for all lines of bowling in any other practice prior to the tournament. Tournament competitors not paying for all lines of bowling in any other practice session shall be found in violation of PWBA code of conduct. See Rule 24: Fines and Penalties.
 1. After tournament competition begins, competitors may practice any time there are lanes available that are not being used for competition. Lanes must be stripped of the tournament pattern before use with the approval of the Tournament Director.
 2. Competitors who are still competing in the tournament may not practice on a competition pair after tournament competition begins. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 3. When possible, practice pairs with the tournament pattern will be made available to all match play finalists. All practice sessions are optional.
- C. Warm-Up – The warm-up period will consist of ten (10) minutes of practice on the starting pair of lanes immediately prior to the start of each round. Additional time may be added to the warm-up period at the discretion of the Tournament Director.
 1. An alternative warm-up because of delay between games in any one session may be made at the discretion of the Tournament Director.
 2. Warm-up period for match play or rounds following a cut to the field, will consist of ten (10) minutes of practice on the starting pair of lanes prior to each round.
- D. Stepladder Final Procedures – This applies to National Tour Standard Events, all events in the Summer Series and all Regional Tour events. Subject to change based on event format.
 1. All competitors will have ten (10) minutes of practice on the championship pair. All seeds not participating in the opening match will begin practice five (5) minutes prior to the two (2) competitors participating in the opening match. A separate warm-up pair will be designated for use by the Tournament Director.



2. The higher seed will have choice of lane at the beginning of each match. The competitor on the left lane will bowl first.
3. Incoming competitors will be allowed a maximum of three (3) practice shots on each lane prior to the start of a match. All other remaining seeds will also receive two (2) practice shots on each lane prior to the start of each match.
4. Prior to the title match, the #1 seed shall receive eight (8) warm-up shots (4 on each lane) on the championship pair.
5. The winner of each match will only be permitted to practice on the alternate lane/pair. The advancing competitor will not get any practice shots on the championship pair between matches.

Rule 7. PWBA PRODUCT USAGE AND SPONSORSHIP GUIDELINES

PWBA or its assignees have the exclusive right to advertise and promote all PWBA events and activities and further have the right to regulate, control and market the use of PWBA names, trademarks and logos.

Rights owned by PWBA may be assigned to a variety of consumer product companies for fair consideration. Rights which may be assigned include titled event sponsorship of tournaments, a series of tournaments, a single tournament, other sanctioned activities or other PWBA assets.

A contracted competitor does not have the right to organize or conduct sales, sampling, couponing or any other type of marketing program directly related to or as part of any PWBA tournament program without the specific approval of the PWBA. Programs which are designed for any purpose other than a contracted competitor's participation as a tournament competitor are the property of the PWBA and may require payment of additional fees to the PWBA.

Rules and policies governing standards and practices by the television network broadcasting any given PWBA tournament may override PWBA's rules.

The PWBA provides opportunities for companies to promote and display their products, product names, logos and trademarks to the consumer public. Companies that desire to take advantage of the promotional opportunities must have their products, logos and trademarks approved by the PWBA.

- A. Approved Companies – Company seeking approval of products, logos or trademarks for appearance in PWBA competition are divided into the categories listed below. A current list of all sponsors can be found here, <https://pwba.com/sponsors>.
- B. Commercial Partners – Any company or business who has negotiated with a PWBA competitor and has been approved by the PWBA on an annual basis. To qualify as a commercial partner, the company must meet the requirements outlined below and comply with the following conditions:
 - a. A company or organization that a PWBA competitor has ownership of
 - b. A company or organization that a PWBA competitor endorses (or with whom they are affiliated)
 - c. A company that is not a direct competitor of any PWBA, USBC or BPAA sponsor, advertiser, charity or business partner.
 - d. A company whose logo does not violate any third-party agreements of the PWBA, USBC or BPAA, including television agreements.
 - e. A company with a business or logo design that is deemed appropriate for display in PWBA competition.
 - f. A company logo that does not violate any known copyrights or licenses held by a third party.
 - g. A company who is considered a small business that generates less than \$15M in annual revenue.
 - h. A company with less than 100 employees.
 - i. A company that does not franchise with multiple locations or operate regionally or nationally.
 - j. A company that is not publicly traded on various stock markets or exchanges.

PWBA shall have the right to refuse to approve any corporation or any product.



If a commercial partner wishes to engage with a PWBA competitor that does not meet the above requirements, they must contact the PWBA to discuss a partnership with the PWBA before they can appear on any PWBA player uniforms. Failure to comply with the following requirements will result in a fine/penalty. See Rule 24: Fines and Penalties.

- C. Television and BowlTV Incentive Prize Rules – Incentive prizes offered to PWBA tournament competitors for use of approved products displaying name/logo/trademarks shall be determined by the owner of the name/logo/trademark.
 - 1. Incentive prize programs offered to PWBA tournament competitors must be provided to PWBA in writing by a designated representative of the owner no later than the start of the first block of the initial round following the first cut in the event. Incentive prizes may be changed up until the start of the first block of the initial round following the first cut in the event.
 - 2. A PWBA competitor who accepts an incentive prize which is in excess of the posted incentive prize shall be in violation of the PWBA Code of Conduct. See Rule 24: Fines and Penalties.
 - 3. Any approved product used during the television finals of a tournament must be in the same form and condition as it is commercially sold. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 4. Incentive Offers – All incentive offers must be approved by the PWBA. Incentive offers shall be construed as anything of value. All incentive offers must be made available to the entire tournament field. All incentive offers will become effective as soon as posted in the locker room by the PWBA.
- D. Event Title Sponsorship – Titled event sponsorship for any PWBA tournament during the calendar year may be offered by PWBA to any company at a fee per tournament approved by PWBA. For a titled event tournament sponsored by a company other than an approved corporation, the sponsor's name(s), logo(s) and/or trademark(s) can be displayed during that specific tournament only.
 - 1. A direct competitor of a title event sponsor may not purchase opening and/or closing billboards for the telecast of a titled event sponsor's tournament.
 - 2. A direct competitor of a titled event sponsor may not purchase paid advertising commercials within the telecast of the titled event sponsor's tournaments.
 - 3. Standards, practices, rules or policies set forth by the television network broadcasting the PWBA tournament may override PWBA television rules and policies set forth herein. PWBA reserves the right to adjust these rules at any time.


Rule 8. WEARING APPAREL, LOGO PLACEMENT AND APPEARANCE GUIDELINES

All logo requirements listed in the following rule must comply with product registration requirements and companies defined within Rule #7 and are the only logos allowed on a player's uniform, provided the logo does not violate Commercial Logo guidelines listed above.

- A. Name on Shirts – All competitors shall wear their required jerseys at all times during competition. All tournament competitors are required to wear their last names (first and last name is recommended) in lettering a minimum of one (1) inch high and a maximum of three (3) inches high, on the back of shirts during all tournament play. Hand-printed lettering is not permitted. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 1. All competitors are required to wear a jersey with the last name they used to enter the tournament.
 - 2. The lettering of names must be legible and in good taste in the opinion of the Tournament Director. Removable name plaques with embroidered or printed lettering are not permitted.
 - 3. Lettering must be in contrasting color to backing (light on dark, or dark on light material) so it can be easily read from a distance.
- B. PWBA and BowlTV Logo – All competitors must wear the PWBA logo on the right sleeve of their shirts. All competitors must wear the BowlTV logo on the right sleeve of their shirts. See Rule 24: Fines and Penalties.
- C. PWBA Sponsor Logos – PWBA competitors must wear any required sponsor patches or logos when mandated by the PWBA.

- D. Commercial Logos – Commercial logos may appear on apparel used during competition in the approved locations as listed in Section E and F
- E. Logo Guidelines for Dye-Sublimated Jerseys –
 1. **Left Sleeve Logo Location (L1, L2, L3)** – The left sleeve has three (3) approved positions (upper, middle and lower or a combination of any two) reserved PWBA approved commercial logos.
 2. **Right Sleeve Logo Location** – The right sleeve of the shirt shall be reserved for use by PWBA and BowITV.
 3. **Left and Right Chest Logo Location (1, 2, 3, 4)** – The upper front of the shirt will carry four (4) approved positions (upper/lower right chest and upper/lower left chest). The upper and lower logo positions may be combined to accommodate one logo not to exceed 12 square inches. Commercial logos in any of these positions require PWBA approval.
 4. **Center Chest Logo Location (5, 6)** – The center chest will carry two (2) approved positions (upper chest and lower chest) reserved for PWBA Gold & Silver levels receive first right to these locations. If competitor is not sponsored by a Gold or Silver level brand, any PWBA approved commercial logo may appear here. Two (2) logo positions may also be combined to accommodate one (1) logo not to exceed 12 square inches wide.
 5. **Abdomen Logo Location (7, 8, 9)** – The abdomen will carry three (3) approved positions (left, center, right) reserved for PWBA approved commercial logos.
 6. **Side Logo Location (10, 11)** – The front side will carry two (2) approved positions (left vertical and right vertical) reserved for PWBA approved commercial logos.
 7. **Front of Collar Logo Location (C1, C2)** – The collar will carry two (2) approved positions (right and left) reserved for PWBA approved commercial logos.
 8. **Back Logo Location (13, 14, 15, 16)** – The back will carry four (4) approved positions (yoke, upper, center and lower back) reserved for PWBA approved commercial logos. Two (2) logo positions may also be combined to accommodate one (1) logo not to exceed 12 square inches wide.
 9. **Back of Collar Logo Location (12)** - The collar will carry one (1) approved position (back) reserved for PWBA approved commercial logos.

NOTE: Combining any two (2) logo positions into one (1) logo shall count as two (2) logos. Combined sleeve and upper chest logos may not exceed 12 square inches or the designated logo space(s).



- F. Logo Guidelines for Non-Dye-Sublimated Jerseys –



1. **Left Sleeve Logo Location** – The left sleeve will carry three (3) approved positions (upper, middle, lower or a combination of any two) reserved for PWBA approved commercial logos.
2. **Right Sleeve and Yoke Logo Locations** – The right sleeve of the shirt shall be reserved for use by the PWBA.
3. **Left and Right Chest Logo Location** – The upper front of the shirt will carry four (4) approved positions (upper/lower right chest and upper/lower left chest). The upper and lower logo positions may be combined to accommodate one logo not to exceed 12 square inches. Commercial logos in any of these positions require PWBA approval.
4. **Center Chest Logo Location** – Positions not approved for non-dye-sublimated shirts.
5. **Abdomen Logo Location** – Positions not approved for non-dye-sublimated shirts.
6. **Front of Collar Logo Location** – The front collar will carry two (2) approved positions (right and left) reserved for individual sponsor logos and/or PWBA approved commercial logos.
7. **Side Logo Location** – Positions not approved for non-dye-sublimated shirts.
8. **Back Logo Location** – Positions not approved for non-dye-sublimated shirts.
9. **Back of Collar Logo Location** – The collar will carry one (1) approved position (back) reserved for PWBA approved commercial logos.

NOTE: Combining any two (2) logo positions into one (1) logo shall count as two (2) logos. Combined sleeve and upper chest logos may not exceed 12 square inches or the designated logo space(s).

- G. **National Flag Patches** – The national flag of any competitor's home country may be substituted for any approved logo position.
- H. **Network Logos** – Competitors may not wear the logo of any television network unless authorized by the PWBA.
- I. **Bowling Pro Shop or Business Logo** – The logo of any bowling pro shop or business may be worn, provided the logo does not violate Commercial Logo guidelines listed above. Logo may not exceed six (6) square inches in size.
- J. **Protruding Items** – Tournament competitors are not permitted to have anything hanging or protruding from their apparel while bowling.
- K. **Appearance Guidelines** – Appearance guidelines will apply to all tournament competitors for all PWBA tournament play, Bowl with the Pros, official practice sessions, informal practice sessions, and any appearance on behalf of the PWBA. Guidelines are as follows:
 1. Competitors may wear dress slacks, capris, shorts, dresses, skirts or skorts. Length of skirt, dresses, skorts or shorts must be below the competitor's fingertips when they are standing and their arms are hanging down at their side. Length of skirt, dresses, skort, and shorts MUST be long enough to not see your bottom area (even if covered by under shorts) at any time, standing or bent over.
 2. Prohibited items while competing:
 - a. Denim.
 - b. Cargo pants or cargo shorts.
 - c. Patch pockets.
 - d. Tank tops.
 3. A competitor's clothing shall be neat, appropriate, and clean, and the competitor shall present a neat appearance in both clothing and personal grooming. All competitors must be in acceptable attire when they are in the tournament bowling center. All tournament competitors must be prepared to be photographed or interviewed on television at any time during the tournament, including practice sessions, Bowl with the Pros, media sessions, all finals and VIP functions.
 4. Examples of prohibited items while in the bowling center:
 - a. Leggings, unless under a skort or shorts,

- b. Workout gear.
- c. Yoga pants.
- d. Sweatpants.
- e. Denim pants.
- f. T-Shirts, unless they are neat and clean and carry the logo of a PWBA product registered company.
- g. Flip-Flops.

5. The Tournament Director shall have discretion to approve or reject questionable apparel. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties

L. Uniform Approval Process - All uniforms manufactured with the PWBA logo, intended for use in PWBA tournament competition, must be submitted for approval to PWBA@bowl.com. Approval must be obtained prior to the uniform's completion to ensure compliance with Rule #8 guidelines. Any uniforms not pre-approved must be presented to the Tournament Director for review before their first use in competition to confirm compliance.

Logos that are not approved or that violate PWBA apparel guidelines must be covered before the start of competition. Alternatively, a different uniform must be worn. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

Rule 9. PRIZE FUND

- A. Prize Distribution – Distribution of prize money will be as published in official tournament literature. An appropriate trophy shall be awarded to the champion.
- B. Revision of Prize List – If required for unforeseen circumstances, the prize list for the tournament may be revised. It shall be the duty of the Tournament Director to revise the prize list to conform as closely as possible to the original prize list.
- C. Split of Tie Position – In the event of a tie for any cash position other than first place, the money shall be divided equally for the positions tied except for positions which specifically call for a roll-off.

NOTE: A competitor that bowls a perfect game during a stepladder PWBA National Tour event receives a \$10,000 bonus. This bonus does not include the PBA/PWBA Striking Against Breast Cancer Mixed Doubles or the PBA/PBA50/PWBA Trios (if applicable). A competitor that bowls a perfect game during a stepladder PWBA Regional Tour event receives a \$1,000 bonus.

Rule 10. LANE MAINTENANCE

- A. A fair, equitable and uniform lane condition for all tournament lanes is the primary objective of the PWBA lane conditioning program. Basic lane maintenance information will be posted in the locker room prior to the start of the tournament.
- B. It is prohibited to discuss lane maintenance procedures with lane maintenance personnel at any time during a tournament. No competitor shall make any public statement concerning lane maintenance procedures, lane conditions or lane maintenance personnel. The lane maintenance personnel shall not be harassed, intimidated nor criticized by any competitor. Any complaint regarding lane maintenance must be made to the Tournament Director. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- C. If there is a change in lane maintenance procedures after the official practice session and before the start of the tournament, the Tournament Director will inform the competitors at roll call.

Rule 11. LOCKER ROOM

- A. Equipment Storage – All bowling balls, shoes and other equipment must be bagged or boxed. All bags and boxes must be labeled with the competitor's name. Failure to properly identify bags or boxes shall result in the removal of the equipment from the locker room. Bags must be zipped and boxes closed. All equipment must

be placed in areas marked or specifically provided. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

- B. Ball Limit in Locker Room – Each competitor will be allowed to keep a maximum of twelve (12) bowling balls in the locker room at any time. Any excess balls that have not been approved by the Player Services Representative shall be removed from the locker room. Ball limit restrictions will be enforced by the Tournament Director. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- C. Security – Wherever possible, the locker room will be locked one (1) hour after the end of competition each day and opened one (1) hour prior to the start of each day's competition. A key will be left at the host center counter and will be available to all competitors needing to enter the locker room.
- D. Trash Disposal – Tournament competitors are required to remove all trash and maintain the area where their equipment is stored in a clean and orderly fashion.
- E. Access to the Locker Room – Only tournament competitors, PWBA staff and approved ball company representatives are permitted to enter the locker room and use all equipment.

Rule 12. BOWLING BALL SPECIFICATIONS

- A. Bowling Balls – All Bowling balls must meet all USBC specifications and be included on the list of USBC approved balls posted on BOWL.com; however, certain bowling balls are ineligible for competition even if they appear on the approved list. This includes all slow oil-absorbing high-performance bowling ball (Urethane) models listed in the section below as well as any slow oil-absorbing high-performance balls produced prior to Aug. 1, 2022. In addition, some of the balls listed are ineligible for other reasons as determined by USBC. The bowling balls listed in Appendix A are considered ineligible under USBC Rules.
 - 1. It is the competitor's responsibility to ensure her equipment is eligible for competition.
 - 2. The PWBA reserves the right to check equipment for compliance at any time.
 - 3. If a competitor uses a bowling ball which is not on the USBC approved list and/or does not meet USBC specifications the competitor will be disqualified from the tournament following the completion of the round and will not receive any competition points.
 - 4. If a competitor uses a bowling ball that is on the USBC approved list but displays a logo that violates any of the guidelines outlined in Rule 7 under "Commercial Partners," then the bowling ball will be removed from competition and the player will be allowed to continue to compete in the tournament.
- B. Damaged Equipment – In the event a competitor's bowling ball is damaged during tournament play in such a fashion that it no longer meets USBC specifications, the competitor must notify the Tournament Director and the ball must be taken out of play immediately. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
- C. Use of Abrasives on Ball Surface
 - 1. Use of abrasives or polishes will be permitted until a competitor bowls her first ball for score in any round of competition.
 - 2. Altering the surface of a bowling ball by the use of abrasives (i.e. Abralon pad or sand paper) or polishes while bowling in PWBA competition is prohibited.
 - a. If the competitor alters the surface of a ball but does not throw the ball for score, the ball shall be removed from the playing area until the end of the round.
 - b. If the competitor throws the altered surfaced bowling ball for score, she will be disqualified from the tournament. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - c. The Tournament Director may allow a player to remove foreign substances from the bowling ball surface with authorized cleaners on a case-by-case basis.
 - 3. Use of abrasives or polishes will be permitted during the warmup period prior to a one-game roll off. Regardless of whether the tournament is a single squad or multiple squad tournament.

4. Use of abrasives or polishes will be permitted between matches for all competitors during any stepladder finals. Televised or BowlTV.
5. Altering the surface of a bowling ball by the use of abrasives or polishes during a round robin match play position round is prohibited.

D. Use of Ball Cleaning Machine – Use of a cleaning machine on the tournament premises is permitted before or after competition. Cleaning machines may not be used during competition, and all ball cleaners or other materials applied to the ball surface by a cleaning machine must meet all USBC specifications. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

E. Foreign Material on Surface of Bowling Ball – While bowling in PWBA competition, a bowling ball cannot have any foreign material on it including, but not limited to, powder, rosin, marker or paint. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

NOTE: A player cannot pat their ball with rosin or powder and wipe it down before it is delivered. Wiping the ball with a towel does not make the ball compliant to the rule. Patting a ball with rosin or powder is adding a foreign substance to the ball and cannot be done during competition. A product can only be applied to a bowler's hand and not leave residue on the surface of the ball.

Rule 13. REGISTRATION OF EQUIPMENT

- A. Registration of Balls Used in Competition – The serial number of all bowling balls used during any frames of competition must be recorded on the competitor's scoring recap sheet. Once a ball has been used during any frame of competition, it must be immediately recorded on the competitor's recap sheet. Each ball must be described accurately by the competitor including make and serial number. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
- B. Handling Another Competitor's Equipment – A competitor may inspect another competitor's equipment on the lanes, but she is not permitted to insert her fingers into the ball holes. Any competitor who handles another competitor's equipment or property without the owner's permission shall be in violation of the PWBA Code of Conduct. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

Rule 14. BOWLING BALL INSPECTION PROCEDURES

- A. Use of an Illegal Bowling Ball – Bowling ball checks may be done as deemed necessary by the Tournament Director. A competitor is subject to disqualification and forfeiture of all points and prize money earned from the tournament if any bowling ball recorded on the competitor's scoring recap:
 1. Cannot be produced within thirty (30) minutes after being requested by the Tournament Director.
 2. Does not meet specifications as stated in Chapter 8 of the USBC Playing Rules Book or the USBC Equipment Specifications and Certifications Manual.
 3. Is knowingly tampered with to no longer meet USBC Specifications as stated in the USBC Equipment Specifications and Certifications Manual (USBC Rule 17a-1).
 4. The bowling ball is not PWBA product registered
- B. If a competitor suspects that a bowling ball used by another competitor does not meet specifications, or was tampered with, they must inform the Tournament Director in writing. Tournament Director reserves the right to request evidence the participant violated Rule 14a-1 before securing the ball for inspection.
 1. The Tournament Director will notify the competitor and inspect the bowling ball in question at a time of the Tournament Director's choosing. A decision will be rendered as soon as the appropriate measurements or USBC field test can be completed.
 2. If the ball passes inspection, the competitor who requested the inspection will be assessed a Code of Conduct violation. See Rule 24: Fines and Penalties. The decision of the Tournament Director shall be final.
 3. If the ball fails inspection, the ball shall be removed from competition and confiscated to prevent further use. Competitor shall only be subject to disqualification if there is a Rule 14 violation.

Rule 15. SPECIAL RULINGS

- A. Breakdown or Delay – If a delay or mechanical breakdown of 10 minutes or longer occurs during competition, tournament management will authorize two (2) warm-up shots prior to the restarting of competition. The timing will begin when the Tournament Director is notified.
 - 1. An alternate pair shall be used whenever possible when awarding warm-up in the event of a breakdown.
 - 2. If an alternate pair is not available, two (2) shots will be awarded on the lane opposite where the competitor will throw her next shot for score.
 - 3. If a breakdown requires competitors to move to an alternate pair not previously used in the tournament, each competitor required to move will receive two (2) warm-up shots on each lane.
 - 4. If the breakdown lanes are repaired during competition, it will remain out of play for all squads unless a re-oil occurs. The pair may be brought back into play if needed due to additional breakdowns.
- B. Slow Bowling – A competitor has fifteen (15) seconds to start her delivery once the lane courtesy rule has been satisfied.
 - 1. Slow bowling penalties shall be assessed at the Tournament Director's discretion. Generally, slow bowling penalties will be assessed if a competitor (or competitors) fall three (3) or more frames behind the pair they are following. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 2. Slow bowling penalties will be assessed if a competitor routinely misses her turn to bowl. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 3. Competitors are responsible to pace themselves accordingly with the pairs in front of them. No warm-up shots will be awarded due to slow bowling on a subsequent pair.
- C. Slow Play During Televised Stepladder Finals . A twenty-five (25) second shot clock shall be used to enforce slow play rules during televised events. Penalties for shot clock violations will be assessed per game.
 - 1. When Bowling on the Right Lane. A competitor will have twenty-five (25) seconds to start her delivery from the time the opponent steps off the approach.
 - 2. When Bowling on the Left Lane. When moving to the left lane or shooting a spare, a competitor will have twenty-five (25) seconds to start her delivery from the time her bowling ball comes back to the ball return. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 3. The shot clock may be stopped to allow competitors to adjust their equipment. These requests may be approved by the Tournament Director on a case-by-case basis.
 - 4. Personal listening devices and cell phones are not permitted during any stepladder or televised competition.
- D. Lane Courtesy – Competitors must observe one (1) pair lane courtesy at all times. Competitors may not "double jump." Double jumping occurs following a delivery when a competitor on the same pair delivers her ball before one (1) competitor from the pair to the right and one (1) competitor from the pair to the left have made a delivery, unless those competitors are not ready to bowl or give way. Failure to comply will result in a fine/penalty. See Rule 24: for Fines and Penalties.
- E. Re-racks – Competitors will be allowed a maximum of two (2) re-racks per game during qualifying, match play and all stepladder finals.
 - 1. Additional re-racks may be requested from the Tournament Director.
 - a. Additional re-racks will be granted if the Tournament Director feels the rack is not spotted properly.
 - b. Any competitor who takes additional re-racks during a game without permission from the Tournament Director will be given zero (0) for the frame.
 - 2. Competitors are required to place a check mark on their own scoring recap sheets for each re-rack taken adjacent to the game number and notify other competitors on her pair for verification.

- F. Bowling on Wrong Lane – If a competitor rolls a strike on the wrong lane she must replay the frame on the correct lane. If the competitor does not strike, her pin count will stand, and she must shoot the spare on the same lane. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- G. Bowling out of Turn – If a competitor rolls a strike out of turn, she must bowl again in the correct order of play. If she does not, her pin count will stand and she must shoot the spare. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- H. Pinfall/Deadball
 1. All pinfall must be scored. The Tournament Director shall settle any dispute arising over whether the machine knocked over the pins or whether it fell of its own accord.
 2. A request for a dead ball because of interference may be made through the Tournament Director and must be made immediately following the disputed shot.
 3. A tournament official must be called to authorize a dead ball. The following constitutes a dead ball:
 - a. Any pins missing from a rack.
 - b. Any interference with the ball itself
 - c. Other situations listed in USBC Rule 8.

NOTE: Visual or audio interference will not be considered or awarded at any time. Judgment of interference will be at the sole discretion of the Tournament Director.
- I. Dead Wood – If a pin is in the gutter, a competitor must consult the competitors on her pair to determine if the pin is in play or out of play. If any other competitor feels the pin is in play, it must be removed before a shot is thrown.
 1. If the competitor attempts a spare conversion while a pin is in play and the ball contacts the dead wood before leaving the lane surface, she shall receive zero for the shot.
 2. If the competitor attempts a spare conversion while a pin is in play and any pin after coming in contact with the dead wood knocks down one or more pins, she shall receive zero for the shot.
- J. Fouls – USBC rules regarding fouls will be followed.
 1. Should at any time during the shot the foul light flash, it must be scored as a foul. If the competitor wishes to protest the foul, a ruling by the Tournament Director must be called for by the end of the game. The Tournament Director's decision shall be final.
 2. In the event of an intentional foul, the Tournament Director must be notified immediately. The competitor shall receive no pinfall for that delivery and shall receive no further deliveries in that frame. An intentional foul is a foul caused by anything unnatural to a normal delivery and done intentionally, such as kicking at, or stepping over, the foul line. If, in the act of fouling intentionally, the competitor's action is deemed inappropriate, she may incur a Code of Ethics violation. See Rule 24: Fines and Penalties.
- K. Refusal to Bowl – A competitor who refuses to bowl when it is her turn shall be disqualified from the tournament. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- L. Injury Timeout – Competitors may request an injury timeout by notifying the Tournament Director. Competitors may receive up to two (2) injury timeouts per round. Competitors requesting an injury timeout will have five (5) minutes to resume play, or two (2) minutes during a live televised stepladder final. If play is not resumed at the end of the injury timeout, the competitor will be disqualified. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- M. Keeping Settee Area Clean – All tournament competitors are required to remove any tape, powder, or other trash from the competitors' area once their competition is completed. Rosin bags, hand conditioner, and tape may not be placed on hand dryers. Rosin bags, hand conditioner or any other powder substances are to be placed on a towel as a consideration to other competitors and the host bowling center. No foreign substances shall be allowed on or

near the approach under any circumstances. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

- N. Assistance Carrying Equipment – Only tournament competitors are permitted to carry equipment into or out of the locker room, and into or out of the settee area. If a person is assisting in the carrying of equipment, the competitor must remove the equipment herself from restricted areas and equipment must be carried only through areas open to the public. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- O. Equipment in Settee Area – Tournament competitors may only have six (6) bowling balls in the settee area during competition. All competitors must move all of their equipment with them each game. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- P. Sale of Equipment – Competitors may not sell any used equipment within the host bowling center unless sold directly to the host pro shop or proprietor. Equipment may be given away.
- Q. Alcohol and/or Controlled Substances – Any competitor who competes under the influence of alcohol or any controlled substance other than over-the-counter or professionally prescribed medication in violation of federal, state or municipal law or restrictions set by the host bowling center, shall be in violation of the PWBA Code of Conduct and subject to ejection from the tournament and host center.
 - 1. Consumption of alcoholic beverages at any time from the first ball a competitor throws in a block (including practice and Bowl with the Pros) to the last ball a competitor throws in that same block is prohibited. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 - 2. Consumption of alcoholic beverages when a competitor is finished with their competition round will be permitted following the guidelines:
 - a. No drinking in PWBA competition attire.
 - b. No drinking outside of the bar area.
 - c. All alcohol must be in a glass container. No bottles allowed.
- R. Smoking – Smoking is not allowed by any competitor while participating in Bowl with the Pros, practice sessions or tournament competition (tournament competition is defined as the time period from the beginning to the end of each qualifying round and the beginning to the end of each match play round).
 - 1. No smoking will be allowed in the bowling center at any time.
 - 2. No smoking will be allowed in PWBA competition attire.Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
- S. Gambling – Wagering, including card or dice playing, is not permitted under any circumstances. Competitors may enter brackets run and/or sanctioned by the PWBA. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- T. Failure to Meet Financial Obligations
 - 1. Any payment made to PWBA or to any host center by check or credit card which is returned or refused for insufficient funds, or canceled by a stop payment order, shall result in the suspension of all tournament participation privileges until full restitution is made by the competitor. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
 - 2. Subsequent offenders will be subject to penalty and future tournament entries, dues, etc. must be paid for in cash, money order or by credit card for a probation period of one (1) year following the second offense.
- U. Interrupted Tournament – The following procedures will be in effect should events occur at the host bowling center which significantly delay the tournament.
 - 1. Every effort will be made to complete the tournament in its entirety at the host center. The tournament must be completed no later than twenty-four (24) hours after the originally scheduled conclusion for the event. If circumstances preclude conclusion of the event within this timeframe, PWBA will complete as much of the tournament as possible. Format and times may be adjusted by the Tournament Director if necessary.

2. If circumstances require cancellation of the tournament prior to its scheduled conclusion, the prize list available will be paid according to the standings following the last fully completed round. If television finals are required by contract, the seeded competitors to advance to the TV finals will be determined by position at the point of termination.
3. If an alternative bowling center is used to complete the tournament, the tournament will be resumed from the last fully completed frame. If scores are not available, the tournament will be resumed from the last fully completed round.
4. Under these circumstances, the Tournament Director's decision shall be final.

V. Authorized Personnel – The Tournament Director will define the competitors' area prior to the start of competition.

1. Only tournament competitors, PWBA staff and tournament volunteers are permitted in the bowlers' area during competition. Media personnel covering the event may be permitted into the bowlers' area on a case-by-case basis.
2. Manufacturer's representatives are permitted in the bowlers' area only during practice and warm-up sessions. Once competition begins, only competitors and official tournament staff are permitted in the bowlers' area. All authorized personnel in the bowlers' area during competition must be wearing appropriate attire. No jeans, shorts, hats, sweatpants or T-shirts are permitted.
3. Competitors not competing on the squad in progress will not be permitted in the bowlers' area. Competitors on the oncoming squad are not permitted to enter the bowlers' area until their starting pair and the adjacent pairs have completed their competition. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties

RULE 16. SCORESHEET

- A. Scoresheet – Each competitor is responsible for her own scoresheet and, as a courtesy, the scoresheet of the competitor in the adjacent clockwise position on the pair (i.e. A is responsible for C, C for D, D for B and B for A).
 1. Competitors must sign their own scoresheet at the conclusion of each block as well as the scoresheet of the adjacent clockwise competitor. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 2. At the conclusion of the game, the competitor who finishes first is responsible for recording all scores for the competitors on the pair. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
 3. Competitors are responsible for ensuring that their score, as well as the adjacent clockwise competitor's game, total and plus-minus scores are correct. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
 4. Competitors have thirty (30) minutes after the completion of a squad or until the round summary sheet is posted, whichever occurs first, to make any correction on a scoresheet without penalty.
 5. If a competitor intentionally rips or crumples her scoresheet, she is subject to a scoresheet fine. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- B. No Score – If a score is not filled in on a competitor's score sheet and is not retrievable by computer or manually, the competitor shall receive a score of zero (0) for that game. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties
- C. Altering Score – Any competitor found to be altering her scores for an advantage will be immediately disqualified from that tournament and subject to a Code of Conduct violation. See Rule 24: Fines and Penalties.

Rule 17. MOBILE/ELECTRONIC DEVICES

The use of mobile/electronic devices during competition will be prohibited. This includes cell phones, tablets, laptops, iPods and electronic devices of any kind. This includes any type of camera. Exception: Competitors may use their mobile device only at the end of a game and only in the Players Locker Room. All other locations

in the host venue will be prohibited. Devices used during competition will be confiscated. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.

Rule 18. ELECTRONIC MEDIA

PWBA recognizes electronic media is an important tool of communication and fan interaction and has a role in growing the brand of PWBA, tournament hosts and sponsors. In the interest of protecting and growing these brands, PWBA has adopted the following policy.

- A. When using electronic media open to the public, competitors must always use it in a professional manner. It is a violation of the PWBA Code of Conduct to use message boards, conversation pages and other forms of social networking (such as Facebook, Instagram and X) to:
 1. Defame, criticize, or make negative remarks toward fellow PWBA competitors, sponsors, host center or host center employees.
 2. Discuss the sponsor(s), host center or personnel, lane conditions or pins, or her fellow competitors in an unfavorable manner.
 3. Engage in actions unbecoming a PWBA competitor. This includes, but is not limited to, the posting of obscene gestures, inappropriate jokes or pictures, intimate details of one's personal life, or any kind of sexual reference.
 4. Any violation of the above rules will result in a fine/penalty. See Rule 24: Fines and Penalties.
- B. Prior to posting an instructional program, news, guest program, commercial, or endorsement which conflicts with PWBA or IBC sponsors, the competitor must inform the PWBA via the form provided on pwba.com. Failure to comply will result in a fine/penalty. See Rule 24: Fines and Penalties.
- C. If a competitor wishes to record their competition for blogging purposes, they must follow BowlTV requirements. Competitors are not allowed to operate the camera during competition. Please click [here](#) to fill out the appropriate form.

Rule 19. TIE FOR POSITIONS

- A. Tie for Position and Subsequent Roll-off – In case of a tie after the qualifying rounds, the competitor with the highest block will be given the higher position. If there is still a tie, then the competitor with the second highest block will be given the higher position. If all blocks are equal, high game will be used. If a tie for a position results in a roll-off, the competitor with the highest block will be given the option to start the match.
- B. Tie for Last Qualifying Position – A tie after qualifying for the last advancing position will require a one (1) game roll-off to break the tie.
 1. The roll-off will take place on a pair to be determined by the Tournament Director, where neither competitor bowled for the prior two (2) games. The competitor with the highest block will receive choice of starting lane. Should that match result in a tie, a one ball roll-off will be bowled on the same pair of lanes to break the tie. The highest seeded competitor shall determine starting lane and order for the roll-off. The competitors will alternate lanes in the same bowling order until the tie is broken.
 2. Any tied competitor who is not in the host center to participate in a roll-off within thirty (30) minutes following the announcement of the tie will be disqualified from the roll-off.
- C. Position Round Placement – In case of a tie going into a position round, the competitor with the highest total actual pinfall prior to the position round game will be awarded the higher position. If total actual pins are equal, the competitor with the higher qualifying total will be awarded the higher position.
- D. Tie for Stepladder Finals Position - If there is a tie for the final spot in the stepladder finals, a one (1) game roll-off will break the tie. The roll-off will take place on a pair to be determined by the Tournament Director, where neither competitor bowled for the prior two (2) games. The competitor with the higher actual pinfall total for the tournament will receive choice of starting lane. If total actual pins are equal, the competitor with the higher qualifying total will receive choice of starting lane.

1. If there is a tie for any higher seeding position, a one (1) game roll-off will break the tie. The roll-off will take place on a pair to be determined by the Tournament Director, where neither competitor bowled for the prior two (2) games. The competitor with the higher actual pinfall total for the tournament will receive choice of starting lane. If total actual pins are equal, the competitor with the higher qualifying total will receive choice of starting lane.
2. If there is a tie for seed position of the final two spots (pending the number of athletes in the stepladder) the highest qualifier will receive the higher seeded position.

E. Tie in a Stepladder Finals Match – If a stepladder finals match ends in a tie, a one ball roll-off will be bowled on the same pair of lanes to break the tie. The highest seeded competitor shall determine starting lane and order for the roll-off. The competitors will alternate lanes in the same bowling order until the tie is broken.

F. Tie in a Bracket Elimination Match – In tournaments where a bracket elimination format is used, if there is a tie at the end of a game, a one ball roll-off will be bowled on the same pair of lanes to break the tie. The highest seeded competitor shall determine starting lane and order for the roll-off. The competitors will alternate lanes in the same bowling order until the tie is broken.

G. Rules and Regulations – USBC playing rules and regulations shall govern all competition unless modified by PWBA rules.

Rule 20. COMPETITOR GUESTS

Guest passes – All competitors entered in a PWBA event are allowed guest passes for admission to that event for their spouse, school age children under 18, parents, plus one additional guest. These will be distributed on a first-come, first-served basis and limited to a total number of guests that is two (2) times the number of entries in the tournament. For any PWBA competitors who do not qualify for the stepladder finals, if seats are available PWBA competitors will be seated on a first come, first served basis. Stepladder finalists will be allowed four (4) guests for priority seating. Guests will not be seated until just prior to the match in which the guests' competitor competes.

All competitors will be responsible for the conduct of her guests at PWBA events.

Rule 21. SUBSTITUTION OF ALTERNATE COMPETITOR

A. Substitution Procedures – The alternate competitor may enter the tournament in place of a match play finalist at the discretion of the Tournament Director in the case of injury, sickness, or emergency, subject to the following procedures:

1. The alternate's scores shall be computed using her own qualifying total, plus the scratch match-play total of the competitor being replaced.
2. Both the alternate and the competitor being replaced shall receive an amount of prize money equal to one-half the sum designated for the final position of the alternate and that designated for the position of the alternate occupied prior to match play.
3. If the athlete was disqualified, she will forfeit all prize money.
4. The alternate will receive four (4) warm-up shots on a pair determined by the tournament director.
5. In the case of a tie for the alternate position for match play, the competitor with the highest qualifying block score will be given the alternate position.
6. The alternate in round robin match play will be paid \$10 per game that they serve as alternate.
7. The alternate must be present at all roll calls and remain on the premises through all frames of match play competition and be prepared to bowl if required. The alternate must be dressed in bowling attire and ready to bowl at all times during match play.
8. If a competitor declines to serve as alternate, she shall relinquish her alternate's fee and be replaced by the next available competitor based upon finish position.

B. Tour Championship Alternate

1. The total alternate fee for the Tour Championship will be \$1,000. The alternate will be paid for each game they serve as alternate. Example: If a competitor serves as alternate for eight games, they will earn \$333.33. The new alternate (assuming they serve 16 games as alternate) would earn \$666.66.
2. Both the alternate and the competitor being replaced shall receive an amount of prize money equal to one-half the sum designated for the final position of the alternate. The alternate will keep all of her alternate fee earnings. The alternate fee earnings are not split with the competitor being replaced.

C. Alternate for Stepladder Finals – There will be no alternate for stepladder finals in PWBA tournaments.

Rule 22. PWBA COMPETITION POINTS SYSTEM

- A. Competition Points: Competition points shall be awarded to all PWBA competitors for final finishing position in each of these tournaments according to the tables provided.
- B. Points for Tied Positions – Competitors tied for any position shall split the points equally for the two positions for which they are tied.
- C. Points for Alternate – If the alternate replaces an original finalist, the alternate shall receive credit for the final standing position and competition points awarded for that finish position. The original competitor will be awarded points for the alternate's original finishing position.
- D. Point Standings – Competition points shall accumulate throughout the calendar year, updated at the conclusion of each tournament.
- E. Points for Disqualification - No points will be awarded if an athlete is disqualified from the event.

Rule 23. CONDUCT OF ALL TOURNAMENT COMPETITORS

All tournament competitors must always conduct themselves in a professional manner, not only in PWBA events, but in all other tournaments and appearances on behalf of the PWBA. Any public criticism that, in the opinion of the Tournament Director, defames the integrity of the PWBA, officers or staff, shall be a Code of Conduct violation. See Rule 24: Fines and Penalties.

The following list illustrates conduct which is inappropriate for an individual bowling in a professional event. Violations of this Code of Conduct (COC) will be enforced with the appropriate fines and penalties.

- A. Level 1 Infractions – Individuals will receive a warning prior to being issued a code of conduct violation.
 - 1. Double jumping.
 - 2. Slow bowling.
 - 3. Bowling on wrong lane or out of turn.
- B. Level 2 Infractions
 - 1. The use of mobile/electronic devices during competition will be prohibited. This includes cell phones, tablets, laptops, iPods and electronic devices of any kind. Exception: Competitors may use their device only at the end of a game and only in the Players Locker Room. All other locations in the host venue will be prohibited. Devices used during competition will be confiscated.
 - 2. Competitors on incoming squads may not enter the bowlers' area until the previous squad has finished.
 - 3. Smoking and/or drinking during competition.
 - 4. Failure to participate in an assigned pro-am squad.
- C. Level 3 Infractions - Shall apply to all tournament bowlers and credentialed manufacturer's representatives from the time of entry into the competition, through the duration of the tournament, and until the end of the next season's event.
 - 1. One must conduct themselves in a professional manner while in the host center, on the property of the host center and on social media.
 - 2. One must not defame, criticize or make negative remarks toward her fellow competitors, tournament staff, sponsors, host center or host center employees, lane conditions or pins in an unfavorable manner.
 - 3. One must not use electronic media platforms to defame or otherwise attack the integrity of sponsors, other participants, tournament staff, host center or host center employees.
 - 4. One must not engage in improper tactics or conduct including, but not limited to:
 - a. Physical and verbal abuse toward another person.
 - b. Destruction of property. Individual will be held responsible by USBC for replacement/repair of any damaged property.
- D. Bowling Equipment Infractions
 - 1. Ball is marked incorrectly on a player's card and is used in competition.
 - 2. Altering a ball after ball card is submitted that affects the weight or balance of a ball.
 - 3. Requesting an inspection of a bowling ball that passes inspection.
- E. Serious violations which may warrant disqualification from the competition and/or disciplinary action through PWBA will be discussed with PWBA Management.

Rule 24. FINES AND PENALTIES

Violations of PWBA rules and penalties specified previously within PWBA's Official Rules and Regulations shall be enforced by PWBA. Fines and penalties will be invoked under the definitions set forth as follows:

Rule 25. APPEALS

- A. Any competitor subject to disciplinary action shall first be notified of such proposed action in writing within ten (10) days of the date of the violation. Such notice may be presented to the competitor by the Brand Manager or the Director of Operations.
- B. A competitor may appeal an infraction or a penalty within ten (10) days of notification of the infraction or penalty to the USBC Rules Department in writing. A competitor who has formally appealed her penalty shall retain her competition privileges pending final decision. If the penalty is upheld, the penalized competitor must serve her suspension or pay her fine at the next tournament following that decision.



Rule 26. PAYMENT OF FINES

Tournament management will charge all fines to the credit card used by the competitor to enter the tournament unless the individual chooses to have the fine paid:

- A. By cash or credit card. If a competitor fails to pay prior to the conclusion of the tournament, tournament management will use the credit card on file.
- B. Through deduction from the competitor's prize earnings.

Rule 27. TOURNAMENT MANAGEMENT

Tournament management has the final authority to make interpretations of any tournament rule and make decisions regarding anything not covered in the rules.
